BACKGROUND

The Scholarship is an extension of the BUS admission scholarship for local students/ Mainland students to international students. It aims to attract and reward outstanding international students to study in the Bachelor of Business Administration (Hons) Programme ("the BBA Programme" for short) of Hong Kong Baptist University.

ELIGIBILITY¹

- International students (non-Mainland), who enter Hong Kong for the purpose of education with a student visa/ entry permit issued by the Director of Immigration.
- Candidates must meet the university minimum entrance requirement. Given the diversity of education qualifications around the world, please refer to the Academic Registry website for the most up-to-date information².
- Student has demonstrated excellent communication skills and great passion in studying the BBA Programme during the admission interview.

AMOUNT OF SCHOLARSHIP

- A Scholarship of \$40,000 will be awarded to applicants who i) have academic qualifications significantly higher than the university minimum requirement and ii) demonstrate excellent performance in the admission interview. There is no maximum quota.
- A Scholarship of \$20,000 will be awarded to applicants who i) have satisfactory academic qualifications higher than the university minimum requirement and ii) demonstrate good performance in the admission interview. There is no maximum quota.
- The scholarship money will be applied to the recipient's tuition fee installments for the first semester of his/her Year-1 study.

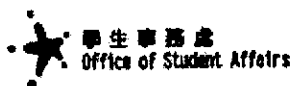
