

It is my great pleasure to invite you to join us for the Philipp Schwartz and Inspireurope Stakeholder Forum, which will take place as a virtual event on 26 and 27 April 2021.

The 2021 Stakeholder Forum will be jointly convened by Inspireurope and the Alexander von Humboldt Foundation's Philipp Schwartz Initiative. It will bring together up to 400 scholars, host institutions, and partner organisations across Europe to discuss topics related to the protection of academic freedom and the support of at-risk academics.

Inspireurope is a joint project of ten partner organisations across Europe – among them the Alexander von Humboldt Foundation – that are committed to the protection and support of researchers and academics at risk. Funded under the European Commission's Marie Skłodowska-Curie Actions and led by Scholars at Risk Europe at Maynooth University, Ireland, the project anchors the work already underway on a national level in different European countries, and lays the groundwork on a European level for durable support structures.

Acknowledging the growing pressures on academic freedom in regions across the globe, the 2021 Philipp Schwartz and Inspireurope Stakeholder Forum will highlight the state of academic freedom in Belarus, Brazil, Turkey and elsewhere. It will reflect on the situation and the work of displaced scholars who have found refuge in other countries, and highlight the work underway in Europe to support at-risk academics and to strengthen academic freedom. It will also look back at the first five years of the Philipp Schwartz Initiative.

In collaboration with Academics in Solidarity, a mentoring programme hosted at Freie Universität Berlin, a particular focus will be placed on offering hands-on coaching and information sessions for at-risk academics. Other sessions will offer networking and mutual learning opportunities for academic mentors and other representatives of host institutions.
